AGREED ORDER OF FORFEITURE

This cause came before this court on a motion ore tenus and it being announced to the Court that the parties have compromised, settled and agreed on the matter involved therefore. The parties agree that this Court enjoys jurisdiction of both parties and the subject matter herein and that the Jackson Municipal Airport Authority had probable cause to initially seize the property which is the subject of this civil action and that the District Attorney of Rankin County filed a Petition for Forfeiture on or about March 6, 2017 and that the Claimant, Ashley Tami Renee Phillips filed an Answer to Petition for Forfeiture on or about April 6, 2017. The Court finding that the parties have settled the dispute in the pleading filed herein, finds that the Motion is well taken and that the same should be granted.

The Court finds that **FIVE THOUSAND DOLLARS (\$5,000.00) IN UNITED STATES CURRENCY** should be forfeited to the Jackson Municipal Airport Authority to be used or disposed of according to law and all property rights of any other person or parties or claims thereto are denied.

The Court further finds that **TWENTY-FIVE THOUSAND DOLLARS (\$25,000.00) IN UNITED STATES CURRENCY** should be returned to the Claimant, Ashley Tami Renee Phillips by and through her attorney Jad Jamal Khalaf, Esq.

IT IS, THEREFORE, ORDERED AND ADJUDGED that **FIVE THOUSAND DOLLARS (\$5,000.00) IN UNITED STATES CURRENCY** is hereby forfeited to the Jackson Municipal Airport Authority to be used or disposed of according to law and that all property rights of any other person or parties or claims thereto are denied and that **TWENTY FIVE THOUSAND DOLLARS (\$25,000.00) IN UNITED STATES CURRENCY** is hereby returned to the Claimant, Ashley Tami Renee Phillips by and through her attorney Jad Jamal Khalaf, Esq.

IT IS, THEREFORE FURTHERMORE, ORDERED AND ADJUDGED that the civil forfeiture action in the above-styled and number cause is hereby dismissed.
